You can send in your dossier to AGCI when you have all documents except the following ready and apostilled, if applicable:

- USCIS Notice of Approval
- Ministry of Justice Application

Please send AGCI one scanned copy of your full apostilled dossier BEFORE mailing to us for review. Then, when reviewed, please mail one printed colored photocopy of the apostilled dossier documents along with the original documents to your IAS. Use the order of this checklist to submit all documents. Please confirm the address with your IAS. Please do not unstaple any apostille pages when making photocopies.

**Fees Due:** Please also provide the dossier fees at the 9 month from contract date. We will need this payment and all Dossier paperwork outside of the USCIS approval and Ministry of Justice application before 10 month mark to avoid late fees. These can be found on your fee schedule or an invoice that can be sent to your family. You can pay via credit card or a check.

AGCI will do a final review and approval of the dossier AFTER the USCIS approval and Ministry of Justice application are approved and received. Then, the full dossier will be mailed to Bulgaria for translation and registration.
