

FOREIGN TRAVEL RELEASE

In consideration of being permitted and authorized by All God's Children International (AGCI) to participate in any manner in travel to a foreign country with or through AGCI, and to participate in any organizational activities incidental to such travel, the undersigned acknowledges and agrees to the following provisions of this release.

1. AGCI is hereby released and held harmless from any and all liability, claims, or demands for damages which the undersigned presently has or may have in the future, arising out of any personal injury, emotional distress, bodily injury, sickness, death, loss of property, property damage, or any other loss, costs or expenses incurred by the undersigned, during the course of, as the result of, or in any way connected with the undersigned's foreign travel as described in this release, whether such damages, costs, or expenses may arise out of the negligence or carelessness of AGCI or otherwise. This release and hold harmless specifically extends, without limitation, to claims based on allegations of failure to warn of circumstances or conditions within any foreign country, or failure to warn of any U.S. State Department travel advisory or travel warning.
2. This release extends to all travel by the undersigned to and within any foreign country, including any and all connections, stopovers, transfers, and domestic portions of such travel. This release extends to all travel by the undersigned which is in any way connected with (a) a past, present, or potential AGCI adoption, including but not limited to travel for the specific purpose of identifying a child, taking placement of a child, finalizing an adoption or guardianship, completing any legal procedure, or otherwise; (b) participation in any foreign travel group facilitated or escorted by AGCI, including but not limited to any group travelling to visit AGCI or other child caring facilities, foster homes, orphanages, or to confer with officials, lawyers, doctors, caregivers, or other persons involved in any way in providing care for children; or (c) travel as a volunteer on behalf of or in relation to the business of AGCI. This release extends to any and all activities incidental to the travel described herein, in whatever manner those activities may occur and for whatever period those activities may continue. This release applies regardless of the capacity of the undersigned, whether the undersigned is a volunteer, an interested person, a donor, a sponsor an adoptive parent or potential adoptive parent, or an accompanying friend, relative, family member, or associate of an adoptive parent or potential adoptive parent or has some other relationship or capacity to AGCI.
3. This release extends to and includes all directors, officers, domestic and international employees, agents, principals, contractors, representatives, successors, assignees, sponsors, volunteers, associates, affiliates, attorneys, and insurers of AGCI; to all other persons and entities subject to

liability derived from the conduct of AGCI; and to any vicarious liability of AGCI based on the conduct of any other person or entity.

4. This release is binding upon the family, estate, heirs, representatives, successors, assigns, officers, agents, and employees of the undersigned.
5. The undersigned acknowledges and is aware that: (a) All travel, whether in the U.S. or a foreign country, involves risks of crime and accident. (b) Foreign travel as described in this release may involve additional risks and hardships, foreseen and unforeseen, including, but not limited to risks of exposure to illness or disease, unsanitary or unsafe food and water, inadequate or non-existent medical and dental services, and political instability. (c) Foreign travel is entirely voluntary. With this knowledge, the undersigned hereby agrees to assume all risks in connection with the foreign travel described in this release, whether such risks are foreseen or unforeseen.
6. The undersigned agrees that the presence or participation of an AGCI employee, agent, facilitator, guide, or travel escort during any portion of foreign travel does not in any way constitute a guarantee, promise, or assumption of responsibility on the part of AGCI for the undersigned's health or safety. Nevertheless, the undersigned acknowledges that he or she has been strongly advised to remain at all relevant times with the AGCI travel group (where the undersigned has been assigned to an AGCI travel group) and to follow and heed the instructions and warnings of the AGCI guide or travel escort. This release extends to any consequence that may befall the undersigned as a result of leaving or separating from the AGCI travel group or from failing to heed the advice or warnings of the AGCI guide or travel escort.
7. The undersigned has had a recent medical examination, or otherwise has good reason to believe that he or she is physically fit and capable to participate in foreign travel, and assumes the responsibility of fitness and capability to do so.
8. The undersigned consents to medical and dental treatment by AGCI, or by such others as AGCI may designate, if the undersigned is in need of such treatment and is unable to consent to such treatment due to physical, mental or other incapacity while participating in foreign travel as described in this release. The undersigned agrees to pay all charges for such treatment and to indemnify and hold AGCI harmless there from. The undersigned further agrees that the rendering of any medical or other services to the undersigned by, or at the instance of, AGCI, or any of the persons or entities described in paragraph 3, above, does not constitute a waiver or an admission of liability to provide or to continue to provide any such services.
9. The undersigned understands that AGCI provides no medical or dental insurance coverage for the undersigned's foreign travel, and that the undersigned is solely responsible for arranging and paying for any such insurance coverage.

10. The undersigned further agrees to indemnify and hold harmless AGCI and all persons or entities described in paragraph 3, above, from any loss, liability, damage, expense, or cost AGCI, such persons or entities, might incur as the result of the undersigned's foreign travel as described in this release.
11. The undersigned consents to medical and dental treatment by AGCI, or by such others as AGCI may designate, if the undersigned is in need of such treatment and is unable to consent to such treatment due to physical, mental or other incapacity while participating in foreign travel as described in this release. The undersigned agrees to pay all charges for such treatment and to indemnify and hold AGCI harmless there from. The undersigned further agrees that the rendering of any medical or other services to the undersigned by, or at the instance of, AGCI, or any of the persons or entities described in paragraph 3, above, does not constitute a waiver or an admission of liability to provide or to continue to provide any such services.
12. The undersigned understands that AGCI provides no medical or dental insurance coverage for the undersigned's foreign travel, and that the undersigned is solely responsible for arranging and paying for any such insurance coverage.
13. The undersigned further agrees to indemnify and hold harmless AGCI and all persons or entities described in paragraph 3, above, from any loss, liability, damage, expense, or cost AGCI, such persons or entities, might incur as the result of the undersigned's foreign travel as described in this release.
14. AGCI strongly recommends that the undersigned not travel to a foreign country for which a U.S. State Department travel advisory or travel warning is in force, and that the undersigned consider either (a) postponing the trip until the travel warning or travel advisory has been lifted, or (b) choosing to adopt a child from another country. This release, waiver, and indemnity agreement applies to any and all foreign travel as described in this release, regardless of the existence of any U.S. State Department travel advisory or warning.

I have carefully read this release and fully understand its contents. I am aware that this is a release of liability and a contract between myself and AGCI and/its affiliated organizations. I understand that by signing this document I am giving up substantial rights, including my right to sue. I sign this document voluntarily, of my own free will. In doing so, I am relying on any representations, statements or inducements other than those that appear in writing in this release.
